Essential:

- Professional experience, post qualifying.
- Requirement to be registered with a relevant professional organisation.







- You will be required to maintain evidence of continuing professional development in the agreed format.
- Experience of working with older people, people with physical disabilities, adults with learning disabilities and sensory impairment and their carers.

- Experience of working in an Intermediate Care/Hospital Environment

Essential:

- Excellent written and verbal communication.
- Excellent assessment skills
- Ability to undertake: -
 - Mental Capacity Assessments
 - Participate in Best Interest Decision making.
- Knowledge and understanding of: -
 - Delayed Transfers of Care
- Knowledge of relevant legislation including: -
 - > Care Act 2014.
 - Mental Capacity Act 2005
 - Mental Health Act, 1983

- Working within multi-disciplinary and multi-interdisciplinary team settings

Special working conditions

Method of Assessment – D, I

Essential:

- The post holder must possess a full driving licence and provide a car for business use. Alternative travel arrangements will be discussed with disabled candidates.
- Ability to work from home on a regular basis, with the requirement to attend your primary work base as and when required.
